Glenview Sustainability Plan Update

Our October 2024 bulletin mentioned that we identified issues with the scope and clarity of the Village's October 2 Request for Proposal (RFP) for consulting services to create and implement an environmental sustainability plan. Thus, it was no surprise that only three bids were received. Village staff recommended the contract be awarded to the most comprehensive proposal, even though it was the highest bidder (a departure from customary practice). Blue Strike

Environmental, headquartered in Monterey, CA will develop the Sustainability Plan. Blue Strike will subcontract implementation to local consulting engineering firm Baxter & Woodman. Baxter & Woodman has an established relationship with the village, currently providing third-party civil engineering review.


The Glenview Board of Trustees approved the \$124, 200 (with an \$8,000 contingency) contract at its December 3 meeting. A plan is expected to be finalized by the end of the summer.

Here's where you come in! In a notable change from the RFP, input from the public will be expanded. Rather than holding a single open house at the beginning of the process to gather input on what the public would like to see, the village has added three focus groups to the preliminary information gathering process. It is worth noting that after reading about the RFP in our October bulletin, several Greener Glenview subscribers with particular expertise in environmental sustainability submitted comments to the Village regarding specific defects in the RFP.

It is Greener Glenview's opinion that their feedback to the Village encouraged this expanded call for public input in the Sustainability Plan process. Your attendance at the open house and/or focus groups and making your voice heard on the issues you care about will be critical in creating a comprehensive and effective plan. Greener Glenview will keep you informed on times and dates and other details as they become available.

Winter Food Scrap and Yard Waste Composting Through Groot Now Available

Plans for 2025

This year will be a particularly important year for the environment and sustainability in Glenview. We have big plans and hope you will find something in which to be involved.

- 4. Present programs on the environmental status of the Great Lakes (Alliance for the Great Lakes); new environmental laws (Illinois Environmental Council); recycling update (SWANCC); among others
- 5. Apply for Judy Beck grants
- 6. Host several informal and formal meetings

Recycle Your Christmas Tree and Holiday Lights (through January 31)

TREES

Can be dropped off until January 31 at these designated collection points:

- Glenview Public Works, 2498 East Lake Avenue
- Johns Park. 2101 Central Road
- Flick Park, 3600 Glenview Road
- Cunliff Park. 540 & Dane
- Cole Park, 1031 Kenilworth Avenue
- Willow Park. 2600 Greenwood Avenue
- Gallery Park, 2001 Patriot Boulevard

Alternatively, residents in single family homes, duplexes and multifamily properties that have opted into the Village's refuse and recycling program can put trees, wreaths and garlands out with the regular garbage during the month of January. Groot will collect them at no additional charge. All ornaments, lights and tinsel should be removed from trees. Do NOT cover the tree with a plastic disposal bag.

Multifamily dwellings that arc not part of the Village's waste contract should refer to their management companies for the appropriate method of disposal.

The Dark Side of Outlight Light: Light Pollution and its Effects on the Environment and Human Health

WHEN: Wednesday, January 8 @ 7:30 PM

WHERE: Zoom

HOSTS: Natural Habitat Evanston/Climate Action Evanston

Robert Sullivan, Retired, Argonne National Laboratory will present on the harmful effects of light pollution on wildlife and human health, and what you and your local government can do to reduce the impacts. Life on Earth evolved in conditions subject to only natural sources of light and is adapted to these natural lighting sources and cycles. Many plants and animals depend on natural cycles of light and darkness for optimal health and even survival. Evidence is mounting that artificial light at night (ALAN) affects the behavior, health, and abundance of various living creatures, thereby disrupting natural ecological processes. This presentation discusses how unwanted ALAN—light pollution—harms wildlife and affects human health and well-being. Best management practices for reducing negative impacts of ALAN are also presented.
